WITNESSED, that whereas the party of the first part has been duly empowered by a vote of the majority of the qualified voters present at a school meeting of said school district under the provisions of Section 912 of the Education Law to enter into a contract for the purpose of providing health and social services for children residing in said school district of party of the first part attending non-public schools in said district of the party of the second part for the period of service to begin on **September 1, 2014** and to end **June 30, 2015**.

NOW, THEREFORE, the said party of the first part hereby agrees to pay the party of the second part the sum of \$ 843.03 in one payment, for health and social services to be provided to approximately 1 child(ren) residing in said district of the first part, and attending non-public schools in the Tuxedo Union Free School District, Town of Tuxedo, County of Orange, State of New York.

And the party of the second part agrees with the party of the first part as follows:

- 1. That the services to be provided shall consist of the following:
 - Annual Medical Inspection
 - School Nursing Service
 - Vision and Hearing Tests
 - Tuberculosis Surveillance
 - Examinations for Employment Certificates
 - Notification of Parents Regarding Defects and Follow-Up Speech Correctionists
- 2. The party of the second part will also furnish the following equipment to be used in providing such services if requested by the authorities in charge of the non-public school:
 - Scales
 - -Vision and Hearing Testing Devices
 - Health Record Forms
 - First Aid Supplies

It is expressly agreed by and between the parties hereto that the services agreed to be supplied under this contract shall not include any teaching services.

It is mutually agreed that this contract shall not become valid and binding upon either party thereto until the same shall be approved by the Superintendent of Schools.
