NYSED regulations Part 200.2(e): The selection of an Impartial Hearing Officer must be made from a state approved list of hearing officers who have indicated a willingness to serve in Orange County. The list is maintained in alphabetical order by the State Education Department with new appointees being inserted by State Ed. into the alphabetical order of the list. Selection must be made on a rotational basis and is determined by contacting the next name on the list after the hearing officer who last served the district.
