# Why the Budget increase from \$89, 773, 642?

Proposed on February 16, 2023: \$89,773,642

Proposed on March 28, 2023: \$90,545,203

• Increase \$771,561

- Foundation Aid: High Impact Tutoring Set Aside
  - o Originally: \$771,561 of Foundation Aid specifically allocated or "set aside" for tutoring
  - Currently: We can include in Foundation Aid

- iPads for Students With Disabilities

- Armoured One security glass protection
- Increase in health insurance

### Two Locations:

- Port Jervis High School
- HBE



### **Capital Project - Phase III**

- **High School** renovate auditorium and relocate library
- Chase Field replace track and install turf
- New Elem. School install generator and build parking lot
- Glennette Field replace lights and scoreboard, install turf
- Cost is \$12.325M with approx. 75% state aid
- Upfront: \$12.325M = Fund Balance of \$9.125M + bond \$3.2M
- End: About \$9.325M from state; \$3M from fund balance- **NO tax increase**

## Purchase of 150 Pike Street Building

- Original plan was to spend an estimated \$1.1 M to renovate the ASK kindergarten wing to create a district office
- Purchase price of 150 Pike Street is \$1.7 M (27,000 sq. ft. building)
- Current tenants generate \$150,000 in income
- Saves ASK kindergarten wing for classroom usage
- NO tax increase to taxpayers fund balance will pay for the purchase

## **Land Exchange**

- School District gives the Sullivan Avenue School property to the City
- The City gives the **Statewide Oil property** to the School District
- Sullivan Ave. School hasn't been used in 20 years
- Statewide Oil property would become a parking lot to serve the new elementary school (old middle school) and Glennette Field
- The school's new addition has shrunk the parking lot considerably
- NO COST to the taxpayers for the land swap

### **Amend Student Walking Distances**

- Change secondary student walking distance from 1.6 miles (HS) and 1.4 miles (MS) to 1 mile
- Change **elementary** student walking distance from 1 mile to 0.5 mile
- Proposition will say "to modify its public school transportation eligibility..."
- NO tax increase to taxpayers
